### **Definitions and Interpretation**

Data	collectively all information that you submit to AE Window Cleaning Service Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

- b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;
- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

#### **Scope of this Privacy Policy**

- 3. This Privacy Policy applies only to the actions of AE Window Cleaning Service Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, AE Window Cleaning Service Ltd is the "data controller". This means that AE Window Cleaning Service Ltd determines the purposes for which, and the manner in which, your Data is processed.

#### **Data Collected**

- 5. We may collect the following Data, which includes personal Data, from you:
  - a. name;
  - b. contact Information such as email addresses and telephone numbers;
  - c. Home or Business Address;

in each case, in accordance with this Privacy Policy.

#### How We Collect Data

- 6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - b. data is collected automatically.

#### Data That is Given to Us by You

- 7. AE Window Cleaning Service Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you use our services;
  - c. Contact form;

in each case, in accordance with this Privacy Policy.

#### **Data That is Collected Automatically**

8. To the extent that you access the Website, we will collect your Data automatically, for example:

- a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

#### **Our Use of Data**

- 13. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.

### **Data Retention**

- 16. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this Privacy Policy or until you request that the Data be deleted.
- 17. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

# **Your Rights**

- 18. You have the following rights in relation to your Data:
  - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
  - c. Right to erase the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data -** the right to "block" us from using your Data or limit the way in which we can use it.
  - e. Right to data portability the right to request that we move, copy or transfer your Data.
